

# **Donation Privacy Policy**

Miller's Kids Fund ("we," "us," or "our") is committed to protecting the privacy of our donors and supporters. This Donation Privacy Policy outlines how we collect, use, store, and protect the personal and financial information you provide when making a contribution to our organization.

By making a donation through our website or by any other means, you agree to the terms of this policy.

#### 1. Information We Collect

When you make a donation, we may collect the following information:

- Full name
- Billing address
- Email address
- Phone number (optional)
- Donation amount
- Payment method and transaction details (processed via a secure third-party vendor)

We may also collect information about the purpose of your gift (e.g., in honor or memory of someone).

#### 2. How We Use Donor Information

Your information is used strictly to:

- Process your donation and provide a tax receipt
- Communicate with you regarding your donation, including acknowledgments and updates
- Maintain accurate donation records for accounting and auditing purposes
- Send organizational updates or future appeals (if you opt in)

We do not sell, trade, or rent your personal information to any third parties.

# 3. Donation Processing and Security

All online donations are processed through secure, industry-standard encryption and compliant third-party payment processors. Miller's Kids Fund does not store or have access to your full payment details (such as credit card numbers).

We take reasonable administrative, technical, and physical precautions to protect your information from unauthorized access, disclosure, or misuse.

### 4. Communication Preferences

You may choose to opt out of future communications at any time by:

- Indicating your preferences on our donation form

We respect your preferences and will honor your request promptly.

## 5. Recognition of Donors

Unless you request anonymity, we may publicly acknowledge donor names (not donation amounts) in annual reports or fundraising materials. You may request to remain anonymous by indicating so at the time of donation or by contacting us directly.

# 6. Third-Party Vendors

We may use third-party services to facilitate donation processing, mailing, or email communications. These vendors are contractually obligated to keep your information confidential and to use it only to perform services on our behalf.

# 7. Children's Privacy

We do not knowingly solicit or collect personal information from anyone under the age of 13. If such information is discovered, it will be promptly deleted.
